Valentine's Day Reflection

John 13:35 "By this all people will know that you are my disciples, if you have love for one another."

As I walked into Walmart, I was overwhelmed by the Valentine's Day décor and gifts display that seemed to have arrived on January 2. The balloons, cards, candy and stuffed animals in every shade of pink and red shouted the arrival of the day. I must admit I was a little annoyed. "Can't we have a break from a sales pitch for even a few days?" I wondered aloud. As I think back on that moment, I still wish we could be given a break from the glitz and pressure of our commercial sales, but then I thought about Valentine's Day. Like Christmas, it's a celebration of love! I did my research and found that it has both Christian and pagan roots. The Christian tradition is sometimes attributed to a jailed priest name Valentine signing a love letter, "From Your Valentine." Financial Update: FINAL 2019 TREASURER'S REPORT

We finished 2019 with a negative bank balance of \$2,472.60. Although income was better than usual in December, we finished paying all our apportionments of \$7,555.00 making us a five-star church. Writing that large of a check contributed to the negative bank balance. In January, 2020 we will be paying property taxes of \$2,945.76 on the property at 208 Lucas which we have yet been unable to sell. These are large expenses for us to absorb.

In December we received a large donation from a member to be used solely for the upkeep and care of the church. That money has been set aside for that purpose. However, there are so many maintenance projects needing attention, it is hard to know what to tackle first.

Our property insurance has gone up yet again an additional \$350 per month. The Administrative board will be giving this their attention but we can only hope in getting it decreased. We are also changing electricity utility companies, hoping to reduce rates.

In summary I would like to impress on each member the costs associated with keeping this church on a solid footing. We are trying to save everywhere we can and have proposed a very tight budget (see 2020 budget in your November newsletter). I know there are a lot of fancier things we want – and maybe need a little – but it is imperative we strive to economize. Administrative Council Minutes - January 14, 2020

Erwin Janszen, acting Council Chair, called the meeting to order at 6:04 p.m. Pastor Dave opened with a prayer. In attendance: Leland Singer, Pastor Dave Moreno, Bill Law, Melissa Law, Martha Law, Leslie Machicek, Tony Barber, Marty Rieck, Vanessa Kunefke, Ken Johnson, Maxine Kubecka and Meredith Holub.

Included in the Council packet: Agenda, Finance Report, Monthly P&L Budget Performance, Balance Sheet, Transaction List and a Statement of Cash Flows.

Minutes from the previous meeting were approved. Motion by Vanessa Kunefke, second by Leland Singer, all in favor.

Financial Reports were provided and explained by Martha Law.

We finished December with a bank balance of \$15,663.07 which made us overdrawn in the operating account of \$2472.60 We paid the remaining apportionments in the amount of \$7555.00 which makes us a five-star church. We need to get new signature cards at the bank. There has been a change to our property insurance premium, raising it approximately \$350.00 per month, I recommend the trustees look into the policy and adjust some of the property values. The parsonage is currently being values at \$383,000 which makes the premium \$5796.84 per year. I'll be paying the property taxes about January 20th in the amount of \$2945.76, so that will be a big expense for us. In December we received an individual donation of \$3500 with the stipulation it be used for the care and upkeep of the church. So now the

maintenance fund is \$6967 and the repairs fund is \$4142. We have not yet had to tap into the Johnson Fund. Leland Singer made a motion to accept the Treasurer's Report, second by Tony Barber. All in favor.

A motion to add Maxine Kubecka to the checking account as the Treasurer and keep Wanda Johnson, Martha Law, Erwin Janszen, Linda Curtis and Jimmy Neeley on the checking account was made by Tony Barber, second by Leland Singer. All in favor.

Wesley Nurse, Leslie Machicek reported that Prevent Blindness will be here Monday, January 27th from 10-noon. We have 25 appointments total to fill and have filled 13 of those. They will do a vision screening and if you fail the screening they will mail you a voucher to see an eye doctor in Bay City for prescription and voucher for one free pair of glasses if you qualify. Eyes should be checked yearly, so if you haven't had your eyes checked in over a year, please call me and make an appointment.

A&M Diabetes classes are scheduled for the year. These classes are all day and lunch is provided, 8:30am-4:30pm. This class provides individual education and a year of follow-up support. The dates are as follows:

Tuesday, February 11 – Spanish Tuesday, March 3 – English Tuesday, June 2 – Spanish Tuesday, September 1 – English Tuesday, December 1 – English

Cameo Mead has now joined me to help provide counseling to individuals and families.

Her hours are Thursday 9 to noon in the Parlor. Clients are encouraged to call her and make an appointment. Her number is 361-739-3891. Also asking the board to please consider putting up security camera for the church.

Trustees Report

Leland Singer reported that we sold the Mission house for \$20,000. We cleared \$18,800 after paying 6% commission. 3% went to Sherry Williams, a licensed Texas Real Estate Company and 3% to Texas Coastal Properties. The door to the hot water heater needs to be replaced in the rent house.

Bill Law made a motion to move forward and get 3 professionals to give us a bid on placing of security cameras, consultation and installation. Second by Ken Johnson. All in favor.

Missions report was presented by Marty Rieck. Pat Allen Memorial Christmas Day dinner served around 200 plates. Shoe and Sock drive for 31 students of PISD went smoothly and was well received by the congregation. A thank you note from PJHS was shared. Noisy change offering for the Methodist Children's Home was collected. The amount was \$61.50. Rail offerings for January-Helping Hands Assistance Fund of FUMC Palacios (\$142 rail, \$45 donation in December and \$110 donation later in January. Rail offerings for February- Diaper Pantry/Wesley Nurse (will collect money at rail to buy diapers.) March-Five Star-Missionary Support, April-UMCOR Sunday-5 Star-Used to be One Great Hour of Sharing,

May-UMCOR #901670-Disaster Response-5 Star, June-Kingdom Kamp at Cathedral Oaks-5 Star, July-Helping Hands Assistance Fund, August-Palacios Charitable Fund and our church Mission Fund, September-Helping Hands Assistance Fund, October-Pat Allen Christmas Dinner, November-St. Andrew Society-5 Star, December-Heifer International – 5 Star. Blessing Porch Box and Signage is being removed. New design and location is under consideration, but it will be at our church.

Pastor Dave provided an oral **Pastor's Report**. A discussion about how everyone felt about disconnecting the office phone and getting a basic cell phone. Pastor Dave talked to the District Superintendent about our apportionments. He reported that our apportionments and budget are about the same as other churches our size.

Old Business


